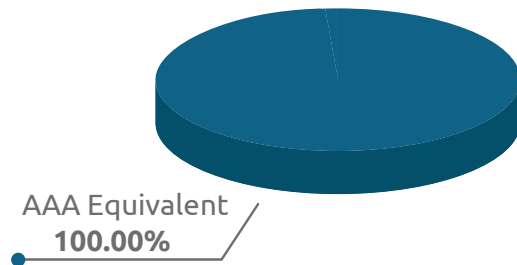
CORE



